WIZF Facebook Page Sweepstakes

OFFICIAL SWEEPSTAKES RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

SWEEPSTAKES DESCRIPTION:

The WIZF Facebook Page Sweepstakes ("Sweepstakes") will begin on December 19, 2011 and end on December 29, 2011 ("Sweepstakes Period"). This Sweepstakes will be conducted exclusively online. Four (4) grand prize winners will each be awarded one (1) check in the amount of \$500.00.

HOW TO ENTER:

Listeners of WIZF-FM who are legal residents of the U.S. residing within the terrestrial listening area of the station, and are 18 years of age or older will be able to take part in this Sweepstakes. To participate in the Sweepstakes, participants must do the following:

- 1. Participants must log on to the station's Facebook page and click the "Like" tab. Once there, they must fill out the online registration form to qualify to win.
